What are the trends in Global Macroeconomic Indicators?

- The global economy grew at 3.2 per cent in 2023; advanced economies and EMDEs grew at 1.6 and 4.3% respectively.
- All major economies have surpassed pre-pandemic GDP levels.
- The Red Sea crisis amid heightened geopolitical tensions in the Middle East eased a year later leading to decline in inflationary pressure.
- Headline inflation across countries declined, however, core inflation remained sticky on account of services inflation and a strong labour market

Bharat a great and prosperous nation by 2047.



♣ Domestic food market to grow 47% to reach \$1274 billion by 2027-Report

The country's food sector is predicted to expand by more than 47% and reach \$1,274 billion by 2027, according to a survey published by the Confederation of Indian Industry and backed by Danfoss India. The report titled 'Food Processing Sector in India — Potential for Southern States' sees creative startups with cutting-edge technology emerging in India's food processing industry. Read More...

Boost to the domestic maritime industry

As of June 2024, India's fleet includes 485 Indian-flagged vessels with 11.95 million Gross Tonnage in overseas trade and 1,041 vessels with 1.7 million GT in coastal trade. With a total of 1,530 vessels and 13.7 million GT, the rise in Indian tonnage highlights the effectiveness of these policies in enhancing national maritime capabilities and preference for Indian vessels. - India's retail inflation hits near five-year low at 3.54% in July India's retail inflation in July dropped to 3.54%, marking a near five-year low as food prices eased. This decline follows a 5.08% inflation rate in June and is the lowest recorded since August 2019. Economists had anticipated a slightly higher inflation rate of 3.65%, but the actual figure fell below the Reserve Bank of India's 4% target, primarily due to a high-base effect from last year. In July 2022, inflation had peaked at 7.44%, driving the comparative drop this year. Read More...
- ♣ Agri trade on e-NAM platform crosses Rs 13,523 crore in Apr-July, FY25 With more states opening up or facilitating trade of agricultural commodities on the government's electronic – National Agriculture Market (e-NAM), trade on the pan-India digital wholesale platform crossed Rs 23,523 crore during April-July of FY25, up 13% on the year. There has also been a significant spike in inter-mandi and inter-state trading of agri-commodities on the digital platform, which currently integrates 1389 mandis across 27 states Read More...
- Mitra Shakti: Indian and Sri Lankan Armies to begin joint exercise

 Next week the Indian Army and the Sri Lankan Army will kick off the 10th edition of their joint exercise, "Mitra Shakti," at Maduruoya in Sri Lanka's Southern Province. This annual event is crucial for fostering cooperation and enhancing interoperability between the two nations' armed forces. "Mitra Shakti" aims to improve the operational proficiency of both armies by facilitating the exchange of skills, experiences, and best practices. Read More...
- As per the report, India's dynamic startup ecosystem is set to attract \$1 billion in new venture funding in 2024, which is 25% higher compared to 2023. A significant portion of this investment will be directed toward AI-focused companies offering significant growth opportunities.
