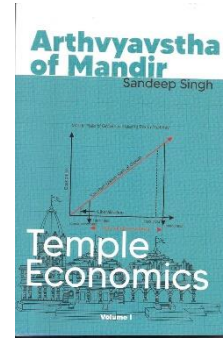

- **Kerala tops ease of doing business rankings**

Kerala, followed by Andhra Pradesh and Gujarat, were ranked as top performers by the Centre under the Business Reforms Action Plan (BRAP) for promoting ease of doing business, according to the Commerce and Industry Ministry. [Read More...](#)

- **Target of Rs 1 lakh crore in seafood exports by 2029, strengthens fishing sector with key initiatives**

Union Minister Rajiv Ranjan Singh said that the government will take steps to fortify the fishing sector's foundation over the next five years, with a particular focus on raising annual seafood exports to Rs 1 lakh crore from roughly Rs 60,000 crore in the previous fiscal year on Wednesday. - **Tax remission benefits extended to e-commerce exports**

To boost exports through e-commerce, the government extended the tax remission benefits available to other exporters for shipments made by courier. The schemes that e-commerce exports through couriers will be eligible for are Remission of Duties or Taxes on Export Products (RoDTEP), Rebate of State and Central Taxes and Levies (RoSCTL), and Drawback. - **Tata Steel inks £500-mn grant deal with UK govt**

Tata Steel has signed a £500-million grant funding agreement with the UK government to help speed up the £1.25-billion green steel project at the Port Talbot steelworks factory. The project involves replacing the blast furnaces with electric arc furnaces and is expected to help reduce the UK's industrial carbon emissions by 8% and Port Talbot's by 90%. [Read More...](#)

MoSPI will begin conducting a new survey to track the capital expenditure of private companies on an annual basis, starting this financial year.
