India and Russia are accelerating efforts to establish a rupee-ruble trade mechanism, aiming to reduce reliance on the US dollar amid growing global financial complexities. The two nations are working to create a direct payment system in their respective currencies, a step that could redefine their trade relationship by fostering greater financial independence. - First e-commerce company with positive cash flow in FY24**
E-commerce company Meesho reported its FY24 audited results with revenue from operations growing by 33% to Rs 7,615 crore, on the back of 36% growth in orders delivered from 62 crore to 84 crore. • Rs 1.25 lakh crore loss to China expected this festive season: CAIT

• Direct tax-GDP ratio at millennial high in FY24

The Centre's direct tax-to-GDP ratio in the financial year reached the highest level in the millennium in FY24, if not the highest ever, reports FE. The ratio, which is a crucial determinant of the country's ability to find resources for physical and social infrastructure projects, and the progressive nature of taxation, came in at 6.64% in the last financial year, up from 6.11% FY23 and 5.97% in FY21.
